## Energy Efficiency PROGRAM

Eligible customers must meet the following criteria:

- Live in a single-family home.
- Must be an Ameren Illinois residential customer heating your home with gas or electricity delivered by Ameren Illinois OR an Ameren Illinois residential electric customer heating your home with propane.
- Maximum gross annual household income at or below the amount listed for your area on the Income Qualification Chart on the next page.

To find out if you are eligible for a free Home Energy Assessment:

1. On the chart on the back of this document, locate the county where you currently live and find it listed on the chart.
2. Using the left-hand column, choose the number of people who live in your household.

To be eligible for the free Home Energy Assessment, your maximum gross annual household income must be at or below the dollar amount listed for your county and household size.
