2024 EQUIPMENT ELIGIBILITY:

Central Air Conditioners (split and packaged units)

- » Eligible for Business and Residential electric customers.
- » Maximum capacity of 64.9 kBtu for Residential customers.
- » Must be 15.2 SEER2 (16 SEER) and 11.88 EER2 (12.5 EER) or greater as confirmed by the Air Conditioner, Heating and Refrigeration Institute (AHRI) for systems less than 65 kBtu.
- » Must be 13.8 IEER or greater as confirmed by AHRI for systems 65 kBtu – 134.9 kBtu.
- » Must be 14 IEER or greater as confirmed by AHRI for systems 135 kBtu – 239.9 kBtu.
- » Must be 13 IEER or greater as confirmed by AHRI for systems 240 kBtu – 759.9 kBtu.
- » Must be 12.1 IEER or greater as confirmed by AHRI for systems ≥760 kBtu.
- » Limit two per Residential account.

Smart Thermostats

- » Eligible for Business and Residential gas and electric customers.
- » Must be ENERGY STAR[®] listed.
- » Limit one per Residential account.

Ducted Air Source Heat Pumps (less than 65 kBtu)

- » Eligible for Business and Residential electric customers.
 - » Note: Commercial packaged units are only eligible for Business electric customers.
- » **Tier 1:** Must be 15.2 SEER2 (16 SEER) and 8.1 HSPF2 (9.5 HSPF) or greater as confirmed by AHRI.
 - » For commercial packaged units, must be 15.2 SEER2 (16 SEER) and 7.5 HSPF2 (9.0 HSPF) or greater as confirmed by AHRI.
- » **Tier 2:** Must be 15.2 SEER2 (16 SEER) or greater as confirmed by AHRI.
- » Limit two per Residential account.

Ducted Air Source Heat Pumps (65-134.9 kBtu)

- » Eligible for Business electric customers.
- » Must be 13.8 IEER and 3.4 COP or greater as confirmed by AHRI.

Ductless Mini-Split Heat Pumps

- » Eligible for Business and Residential electric customers.
- » Must be 16 SEER2 (16 SEER) and 8.55 HSPF2 (9.5 HSPF) or greater as confirmed by AHRI.
- » Limit two per Residential account.

Gas Furnaces

- » Eligible for Residential gas customers.
- » Maximum capacity of 224.9 kBtu.
- » Must be 95% AFUE efficiency or greater as confirmed by AHRI.
- » Limit two per Residential account.

Heat Pump Water Heaters

- » Eligible for Business and Residential electric customers.
- » Must be ENERGY STAR[®] listed.

AX and BX Section Notched V-belt

- » Eligible for Business electric customers.
- » Must be notched belts with AX or BX cross section.
- » Must be suitable for replacement of smooth V-belts between motor and fan in non-residential HVAC RTU systems.

For multifamily complexes, the equipment quantity limits are per housing unit. Example: Limit two central air conditioners per housing unit.

less than 65 kBtu	5.417
65 - 134.9 kBtu	5.417 - 11.242
135 - 759.9 kBtu	11.250 - 63.325
≥760 kBtu	63.333
