# Phase 3 Recap

Phase 3 of the Supplemental Staffing Pilot is currently underway. In partnership with the Department of Commerce and Economic Opportunity (DCEO), Phase 3 will be up to a one-year paid employment training. The candidates will receive on-the-job training that can transfer into practical career skills. The candidates will also receive two certifications as Assessors and Final Inspectors to help achieve and advance their career goals.
